	Answer: No. Net operating cashflows for the September 2021 quarter will reflect the commencement of gold production and receipt of sales revenue. The Company has received funds from its first shipment of gold from the project.

Answer: No. As per the response at 8.8.1, the Company expects to generate sufficient cash through gold sales revenue to fund its operations.
